

## SUPPLEMENTARY DEED OF AGREEMENT

### MIRAMAR CHRISTIAN SCHOOL

*Two* **THIS DEED OF AGREEMENT** is made on the <sup>26<sup>th</sup></sup> day of *January* ~~One thousand nine hundred and ninety-nine (1999)~~ **BETWEEN**  
**PENIEL CHARITABLE TRUST BOARD INC.**, at Wellington  
(hereinafter referred to as "the Proprietor") of the first part and **HER**  
**MAJESTY THE QUEEN** acting by and through the Ministry of  
Education (hereinafter referred to as "The Minister") of the second  
part.

### **WHEREAS**

- A** By Deed of Agreement bearing date of the 24<sup>th</sup> day of January 1991 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement), the Minister and the Proprietor pursuant to section 7 (2) of the Private Schools Conditional Integration Act 1975 established Miramar Christian School, Wellington as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister further agreed on a Supplementary Deed of Agreement which was signed on 29 January 1996.

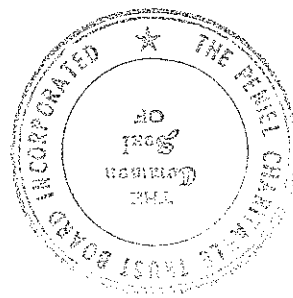
**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY CONVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS:**

- 1. THAT** the words "maximum roll of the School shall be (90) pupils" in line 1 of Clause 6 on page 4 be deleted, and the words "maximum roll of the school shall be one hundred (100) pupils" be substituted therefor.

**2 THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
