## SUPPLEMENTARY DEED OF AGREEMENT

## MONTE CECILIA SCHOOL, HILLSBOROUGH

THIS DEED OF AGREEMENT is made on the 15th day of Described Two thousand and three (2003) BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a "corporation Sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

## **WHEREAS**

- A By Deed of Agreement bearing date the 6<sup>th</sup> day of December, one thousand nine hundred and eighty-two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Monte Cecilia School, Hillsborough** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the words "two hundred (200) pupils" in the 4th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and twenty seven (227) pupils" be substituted therefor.
- 2. THAT in clause 10(b) of the Deed of Agreement the words "five (5) percent of the maximum roll as determined by clause 8 hereof" be deleted from that Agreement and the words "seven (7) pupils" be substituted therefor.
- 3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
