

SUPPLEMENTARY DEED OF AGREEMENT

HAWKES BAY ADVENTIST SCHOOL

THIS DEED OF AGREEMENT is made on the 2nd day of April 1996.

BETWEEN **THE NEW ZEALAND SEVENTY-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED** a charitable entity incorporated under the Companies Act 1955 ("the Proprietor") of the first part

AND **HER MAJESTY THE QUEEN** acting by and through the Minister of Education ("the Minister") of the second part

WHEREAS

- A. By Deed of Agreement bearing date the 28th day of June 1993 as varied by a subsequent Supplementary Agreement bearing date the 10th day of February 1995 (hereinafter together referred to as "the Integration Agreements"), the Minister and the Proprietor pursuant to Sections 7(2) and 7(9) of the Private Schools Conditional Integration Act 1975 firstly establish the Hawkes Bay Adventist Primary School as an integrated school (hereinafter referred to as "the School") and then increased its maximum roll from 65 to 75.
- B. The Proprietor and the Minister are now agreed on amending Clause 20 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 to further increase the maximum roll.

NOW THIS DEED WITNESSES AND IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:-

1. That the words "maximum roll of the School shall be 75" in line 4 of Clause 20 on page 6 be deleted, and the words "maximum roll of the School shall be 104" be substituted therefor.
2. That the terms conditions and agreement contained or implied in the Integration Agreements shall be read and construed subject to the modification herein contained by in all other respects the Integration Agreements are confirmed.
