

INTEGRATION DEED OF SUPPLEMENTARY AGREEMENT

THIS DEED is made the 10<sup>th</sup> day of February 1995

BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED ("the Proprietor") a charitable entity incorporated under the Companies Act 1955

A N D HER MAJESTY THE QUEEN acting by and through THE MINISTER OF EDUCATION ("the Minister")

BACKGROUND:

- A. The Proprietor and the Minister are parties to an Integration Deed of Agreement dated the 28th day of January 1993 in relation to the Hawkes Bay Adventist Primary School ("the Integration Agreement" and "the School") respectively).
- B. The Proprietor and the Minister have agreed that the maximum roll of the School shall be extended and the description of the integrated school premises as defined in the Integration Agreement be varied by the substitution of an existing integrated area (playing area) with a new integrated area (land adjacent the school and one classroom) being the changes provided for in the plan annexed and referred at clause 1 to this Supplementary Agreement.
- C. The Proprietor and the Minister wish to vary the Integration Agreement as they are entitled to do pursuant to Section 9(9) of the Private School Conditional Integration Act 1975.

NOW THIS DEED WITNESSES AND IT IS AGREED BETWEEN THE PARTIES as follows:

1. THE Integration Agreement shall with effect from 10<sup>th</sup> February, 1995 be varied as follows:

- (a) Reference to "65" where it appears at clause 20 of the Integration Agreement shall be deleted and substituted therefor the numerals "75"; and
  - (b) The "annexed plan" referred in and annexed to the Integration Agreement shall be deleted and substituted therefor with the plan annexed to this Supplementary Agreement.

2. THE terms, conditions and agreements contained or implied in the Integration Agreement save and except where expressly modified under this Supplementary Agreement shall continue to apply and the parties hereby mutual covenant that they will respectively perform and observe the said agreements and conditions.
