

THIS DEED OF AGREEMENT is made this 11th day of June 2003

BETWEEN PONATAHI CHRISTIAN SCHOOL TRUST BOARD Body Corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A. By Deed of Agreement bearing date the 1st day of April ¹⁹⁹⁸~~2003~~ as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement") the Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established Ponatahi Christian School as an integrated school (hereinafter referred to as "the School").
- B. The Proprietor and the Minister are now agreed of the need to substitute the plan contained in the second schedule of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH

That it is hereby covenanted agreed and declared by and between the parties hereto as follows:

1. That the plan annexed to the second schedule of the Deed of Agreement shall be deleted and the plan annexed hereto shall be substituted therefore.
2. That the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
