SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 21st day of June One thousand nine hundred and ninety nine (1999)

BETWEEN PONATAHI CHRISTIAN SCHOOL TRUST BOARD a body Corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and

HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A. By Deed of Agreement bearing date the 1st day of April 1998 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established Ponatahi Christian School as an integrated school (hereinafter referred to as "the School").
- B. The Proprietor and the Minister are now agreed on the need to amend Clause 20 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:


1. THAT the words "ninety (90)" in the second line in Clause 20 of the Deed of Agreement, be deleted from that Agreement and the words "one hundred and twenty (120)" be substituted therefor.




2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.



