

SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART COLLEGE, LOWER HUTT

THIS DEED OF AGREEMENT is made on the *Twenty-sixth* day of *July* One thousand nine hundred and ninety-one (1991) BETWEEN THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD a Body Corporate (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 9th day of April 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Sacred Heart College, Lower Hutt as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Building Requirements as defined in the Fourth Schedule to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT page 4 of the Fourth Schedule of the original Deed of Agreement be amended by adding the words "general science laboratory of 81m<sup>2</sup>; laboratory prep room of 14m<sup>2</sup>; technicraft/multicraft; dark room of 7.5m<sup>2</sup>; 2 seminar/study/classrooms of 47m<sup>2</sup>; audio visual store of 14m<sup>2</sup>; Head of Department room of 7.5m<sup>2</sup>; art and craft store of 21m<sup>2</sup>; Technician audio-visual room of 17m<sup>2</sup>; project store of 19m<sup>2</sup>; technician science room of 17m<sup>2</sup>; drama store of 19m<sup>2</sup>;

maintenance staff room of 19m<sup>2</sup>; science workshop of 47m<sup>2</sup>; dangerous goods room of 9m<sup>2</sup>; bookstore of 19m<sup>2</sup>; increase library from 175m<sup>2</sup> to 232m<sup>2</sup>; librarian's office of 9.5m<sup>2</sup>; 8 wcs, 4whb, 4 stdu; increase gymnasium from 334m<sup>2</sup> to 557m<sup>2</sup>. This accommodation is to be provided by 1995".

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
