

SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 3rd day of July One thousand nine hundred and ninety-two (1992) BETWEEN THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD a Body Corporate (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

A By Deed of Agreement bearing date the 6th day of February 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Sacred Heart ^{GIRLS'} College, New Plymouth as an integrated school (hereinafter referred to as "the School").

B The Proprietor and the Minister are now agreed on the need to amend the Building Requirements as defined in the Third Schedule to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT** page 9 of the Third Schedule of the original Deed of Agreement be amended by adding the words "1 standard classroom of 58m²; 1 general science lab of 81m²; 1 lab prep room of 14m²; 1 lecture room of 74m²; 1 student common room of 112m²; 1 advanced laboratory of 84m²; 1 physics prep room of 11.5m²; 1 resource store of 19m²; 5 students w.c's; 3 wash hand basins; 3 sanitary disposal units."

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
