

SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART COLLEGE, HAMILTON

THIS DEED OF AGREEMENT is made on the ^{CVD} 19th day of February One thousand nine hundred and ninety-six (1996) BETWEEN THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD a body Corporate registered under the Religious Charitable and Education Trusts Act 1908 (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 22nd day of September 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Sacred Heart College, Hamilton as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 and the Fourth Schedule of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 **THAT** the words "seven hundred and twenty (720) pupils" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "seven hundred and fifty (750) pupils" be substituted therefor.
- 2 **THAT** the Fourth Schedule be amended by adding under Building Requirements on page 5 the words "two classrooms when the roll requires them."
- 3 **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
