SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART GIRLS' COLLEGE, HAMILTON

THIS DEED OF AGREEMENT is made on the 22 day of November

One thousand nine hundred and eighty-three (1983) BETWEEN

THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD

a body corporate registered under the Religious Charitable and Educational Trusts Act 1908 (hereinafter with its successors referred to as "the proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

## WHEREAS

- The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 22nd day of SEPTEMBER 1980 for Sacred Heart Girls' College, Hamilton (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 2nd day of June 1983 (hereinafter referred to as the "first supplementary Deed of Agreement").
- The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 as amended by the first supplementary Deed of Agreement

## NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1 THAT the words "six hundred and ten (610) pupils" in the 4th and 5th line in Clause 8 of the original Deed of Agreement as amended by the first supplementary Deed of Agreement be deleted from that Agreement and the words "six hundred and fifty (650) pupils" be substituted therefor.

THAT the covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
