

SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART GIRLS' COLLEGE, HAMILTON

THIS DEED OF AGREEMENT is made on the *29* day of *May*
One thousand nine hundred and ninety-one (1991) BETWEEN
THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD a Body
Corporate (hereinafter with its successors referred to as
"the Proprietor") of the first part and HER MAJESTY THE
QUEEN acting by and through the Minister of Education
(hereinafter referred to as "The Minister") of the second
part

WHEREAS

- A By Deed of Agreement bearing date the 22nd day of
September 1980 as varied by any subsequent
supplementary agreements (hereinafter referred to as
"the Deed of Agreement"), the Minister and the
Proprietor pursuant to section 7(2) of the Private
Schools Conditional Integration Act 1975 established
Sacred Heart Girls' College, Hamilton as an
integrated school (hereinafter referred to as "the
School").
- B The Proprietor and the Minister are now agreed on the
need to amend the Building Requirements as defined in
the Fourth Schedule to the Deed of Agreement pursuant
to Section 7(9) of the Private Schools Conditional
Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT page 5 of the Fourth Schedule of the original
Deed of Agreement be amended by adding the words "4
seminar/study/classrooms of 47m² each; 1 advanced
laboratory of 84m²; 1 preparation room of 11.5m²;
library space to a total of 232m²; librarians office
of 9.5m²; 4 toilets for pupils". This accommodation
is to be provided by 1996.
