#### SUPPLEMENTARY DEED OF AGREEMENT

# SACRED HEART COLLEGE, NAPIER

THIS DEED OF AGREEMENT is made on the day of The Out one thousand nine hundred and ninety-six (1996) BETWEEN THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD a Board Corporate (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

## **WHEREAS**

- A By Deed of Agreement bearing date the Twenty-ninth (29) day of March, One thousand nine hundred and eighty three (1983) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Sacred Heart College, Napier as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to replace the Third Schedule attached to the Deed of Agreement with a new Third Schedule pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the Third Schedule to the Deed of Agreement be deleted and replaced with the Third Schedule attached hereto.
- THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
