- B. The Integration Act was subsequently repealed and the rights, duties and obligations of the Current Proprietor and the Minister in respect of the Integration Agreement are now pursuant to Part 33 of the Education Act 1989 ("Education Act").
- B. The Current Proprietor wishes to be released from, and the New Proprietor is willing to assume all of the Current Proprietor's rights, duties and obligations under the Integration Agreement and the Education Act in relation to the School.
- D. The Current Proprietor and the New Proprietor, with the approval of the Minister, now wish to give effect to the change of proprietor by novation of the Integration Agreement.
- E. The Minister is satisfied that the New Proprietor is capable of discharging the responsibilities of the proprietor under the Integration Agreement and Education Act, including responsibility for supervising, maintaining and preserving the education with a special character as defined in the Integration Agreement and Education Act provided by the School.

OPERATIVE PROVISIONS

With effect on and from the Effective Date specified in Clause 6.1:

1. NOVATION OF INTEGRATION AGREEMENT

1.1 The New Proprietor is substituted for the Current Proprietor under the Integration Agreement as if the New Proprietor had been an original party as proprietor under the Integration Agreement.

1.2 All references in the Integration Agreement to the Current Proprietor in any capacity shall be read and applied as if they were references to the New Proprietor.

2. RELEASE OF CURRENT PROPRIETOR

2.1 The Current Proprietor is released from all obligations, duties and responsibilities as proprietor under the Integration Agreement with effect on and from the Effective Date specified in Clause 6.1.

3. ASSUMPTION OF RIGHTS AND OBLIGATIONS BY NEW PROPRIETOR

3.1 The New Proprietor assumes all the obligations, duties and responsibilities of the Current Proprietor and has all the rights and benefits of the Current Proprietor under the Integration Agreement and under the Education Act.

3.2 The New Proprietor is responsible for all outstanding obligations, including obligations arising from any acts or omissions by the Current Proprietor in breach of the provisions of the Integration Agreement or Education Act, as if such obligations, acts or omissions were those of the New Proprietor.

4. TRANSFER OF CURRENT PROPRIETOR'S INTEREST

4.1. The New Proprietor will, within three months from the Effective Date, procure the transfer or assignment of such rights, interests or entitlements of the Current Proprietor relating to the School property that are necessary to enable the New Proprietor to fulfill its duties, obligations and responsibilities under the Integration Agreement and the Education Act as a consequence of the novation.

4.2 The Current Proprietor will execute any documents or other instruments for the transfer or assignment of such rights, interests or entitlements that are reasonably required by the New Proprietor for the purpose of compliance with clause 4.1.

5. MINISTER'S APPROVAL TO NOVATION
