

SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART GIRLS' COLLEGE, NEW PLYMOUTH

THIS DEED OF AGREEMENT is made on the 15<sup>th</sup> day of ~~February~~ <sup>four</sup> ~~1983~~ <sup>1984</sup> ~~1983~~ <sup>1984</sup> BETWEEN

THE INSTITUTE DE NOTRE DAME DES MISSIONS (St Mary's Province)

TRUST BOARD a body corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 6th day of FEBRUARY 1982 for Sacred Heart Girls' College, NEW PLYMOUTH (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

- 1 THAT the second sentence beginning "It is agreed..." in Clause 8 of the original Deed of Agreement be deleted from that agreement and the sentence "It is agreed by and between the parties hereto that the maximum roll of the school shall be four hundred and ten (410) pupils of whom three hundred and twenty (320) shall be pupils in Forms III - VII and ninety (90) pupils in Forms I - II" be substituted therefor.
