

SUPPLEMENTARY DEED OF AGREEMENT

SACRED HEART GIRLS' COLLEGE, NEW PLYMOUTH

THIS DEED OF AGREEMENT is made on the *15th day of August* of One thousand nine hundred and ninety-seven (97) BETWEEN **THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD** a "Body Corporate" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 6th day of February 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Sacred Heart Girls' College, New Plymouth** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to change the class of the school to a **Years 7 to 13 school** consequent upon the closure of **the attached Intermediate Department of the School** pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:


- 1 THAT the Integration Agreement be amended as follows :
- 2 By deleting from **Recital B** the words "Form Three (III) to Form Seven (VII) with an attached Intermediate Department" and substituting the words "Years 7 to 13" therefore.

In **Clause 9** replace "Paragraphs (d) and (e)" with "Paragraph (e)"

Delete the **Fifth Schedule**.

Amend Clause 19 ,	Line 13	change "three" to "one"
	Line 19	change "five" to seven"
	Line 20	change "thirteen decimal three six (13.36)" to "sixteen decimal three six (16.36)"

- 3 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

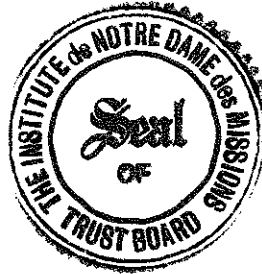
