

**SUPPLEMENTARY DEED OF AGREEMENT**

**SACRED HEART GIRLS' COLLEGE, NEW PLYMOUTH**

THIS DEED OF AGREEMENT is made on the 26<sup>th</sup> day of **MAY** One thousand nine hundred and eighty six (1986) BETWEEN THE INSTITUTE DE NOTRE DAME DES MISSIONS (St Mary's Province) TRUST BOARD a body corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

**WHEREAS**

- A** By Deed of Agreement bearing date the 6th day of February 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established **SACRED HEART GIRLS' COLLEGE, NEW PLYMOUTH** as an integrated school.
- B** The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1** **THAT** the second sentence beginning "It is agreed ..." in Clause 8 of the Deed of Agreement be deleted from that agreement and the sentence "It is agreed by and between the parties hereto that the maximum roll of the school shall be four hundred and twenty (420) pupils of whom three hundred and twenty (320) shall be pupils in Forms III - VII and one hundred (100) pupils in Forms I - II" be substituted therefor.
