

SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 3rd day of *January*

One Thousand nine hundred and eighty *nine* (1989) BETWEEN

THE INSTITUTE DE NOTRE DAME DES MISSIONS (St. Mary's

Province) TRUST BOARD a "Body Corporate" (hereinafter with

its successors referred to as "the Proprietor") of the

first part and HER MAJESTY THE QUEEN acting by and through

the Minister of Education (hereinafter referred to as "The

Minister") of the second part

WHEREAS

A By Deed of Agreement bearing date the 6th day of February 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Sacred Heart Girls' College, New Plymouth as an integrated school.

B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES

1. THAT the words "three hundred and eighty (380)" in the 7th line in clause 8 of the original Deed of Agreement and the words "two hundred and ninety (290)" in the 7th and 8th lines in clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "four hundred and seventy (470)" and "three hundred and sixty (360)" be substituted therefor.

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.




