

## SUPPLEMENTARY DEED OF AGREEMENT

### SANCTA MARIA COLLEGE, HOWICK, AUCKLAND

THIS DEED OF AGREEMENT is made on the *24* day of *August*  
Two thousand and six (2006) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND** a "Corporation Sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A By Deed of Agreement bearing date the 19<sup>th</sup> day of November 2003 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Sancta Maria College, Howick, Auckland** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

1. **THAT** the words
- (i) 450 students from 2004 to December 2005;
  - (ii) 620 students from January 2006 to December 2007;
  - (iii) 820 students from January 2008 to December 2009; and
  - (iv) 1,000 students from 2010."
- in clause 8 (a) of the Deed of Agreement be deleted from that Agreement and *insert*  
the words
- (i) 620 students from January 2006;
  - (ii) 780 students from January 2007 to December 2007;
  - (iii) 920 students from January 2008 to December 2008; and
  - (iv) 1,000 students from January 2009."
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


