SUPPLEMENTARY AGREEMENT TO INTEGRATION AGREEMENT

SUPPLEMENTARY DEED OF INTEGRATION

THIS DEED OF AGREEMENT is made on the 20 day of November 2008

BETWEEN the GISBORNE CHRISTIAN EDUCATION TRUST, a registered charitable entity in terms of the Charities Act 2005 ("the Proprietors").

AND HER MAJESTY THE QUEEN acting by and through the Ministry of Education ("the Minister").

WHEREAS

1. By Deed bearing the date the 28th day of September 1999 (hereinafter referred to as "the Deed"), the Minister and the Proprietor pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 established Sunrise Christian School as an integrated school (hereinafter referred to as "the School").
2. By Supplementary Deed of Integration ("the Supplementary Deed") dated the 22nd day of January 2003, the Minister and the Proprietor both varied and added to the Deed.
3. By Supplementary Deed of Integration ("the Supplementary Deed") dated the 11th July 2005, the Minister and the Proprietor both varied and added to the Deed.
4. By Supplementary Deed of Integration ("the Supplementary Deed") dated the 15th December 2006, the Minister and the Proprietor both varied and added to the Deed.
5. The Proprietor desires to vary the Deed in the manner set forth, in this Deed and the Minister has agreed to such changes pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.


NOW THEREFORE THIS DEED OF AGREEMENT WITNESSETH AND IT IS AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. That the Deed of Integration be amended as follows:
 - 1.1. By deleting clause 1 and replacing it with the following:

"The Minister and the Proprietor agree that the School is to become an integrated restricted composite school pursuant to the Act catering for students from new entrants to Year 10."
 - 1.2. By deleting clause 19.1 and replacing it with the following:

"Sunrise Christian School is a nondenominational Christian School catering for New Entrant to Year 10 pupils. The school was established for the purpose of offering primary education of special character."
 - 1.3. By deleting clause 21 and replacing it with the following:

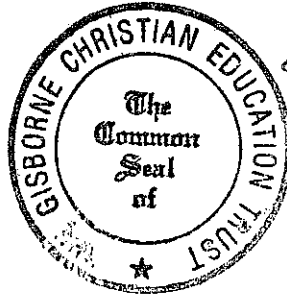
"It is agreed as provided for in Section 7(6)(g) of the Act, that the maximum roll of the School shall be 104 pupils."
2. That the covenants and restrictions contained in the deed shall henceforth be read and construed subject to the modifications set out in Clause 1 hereof but in all respects the Deed of Agreement, the Supplementary Deed and the Deed of variation of the Integration are confirmed.
