**SUPPLEMENTARY DEED OF AGREEMENT**

**INVERCARGILL SEVENTH-DAY ADVENTIST PRIMARY SCHOOL**

**THIS DEED OF AGREEMENT** is made the 29<sup>th</sup> day of January 1997~~8~~

**BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED** a duly incorporated company having its registered office at Auckland (hereinafter with its successors referred to as ("the Proprietor") of the first part

**AND HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as ("the Minister") of the second part

**WHEREAS**

- A. By Deed of Agreement bearing date the 10th day of September 1993 (hereinafter referred to as "The Deed of Agreement") The Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established **INVERCARGILL SEVENTH-DAY ADVENTIST PRIMARY SCHOOL** as an integrated school (hereinafter referred to as "the School").
- B. The Proprietor and the Minister are now agreed on the need to amend the First and Second Schedules of the Deed of Agreement.

**NOW THIS DEED OF AGREEMENT WITNESS THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-**

1. The Proprietor having resolved at a meeting of the Board of Management to amalgamate the land described in the First Schedule to the Deed of Agreement, being Certificate of Title 4A/7, Certificate of Title 6D/456 and Certificate of Title 6D/457 it has become necessary to amend the First Schedule of the Deed of Agreement to describe the land now owned by the Proprietor and to amend the Plan annexed to the Second Schedule.
2. Schedule 1 of the Deed of Agreement be deleted and the First Schedule to follow be inserted therefor:

First Schedule

Description of the total land buildings and other improvements comprising the proprietor's land of which the school premises form part.

The Proprietor's Land

All that land buildings and other improvements owned by the New Zealand Seventh-day Adventist Schools Association Limited Incorporated more or less situate in Bainfield Road, Invercargill and being particularly described as follows and delineated in blue on the plan attached to the Supplementary Deed of Agreement Invercargill Seventh-day Adventist Primary School.

All that parcel of land containing 1.3690 ha situated in the City of Invercargill being Lot 1 DP 13992 and being all the land in Certificate of Title Volume 11B/274 (Southland Registry).

- 3. That the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
