

SUPPLEMENTARY DEED OF AGREEMENT

ST BERNARD'S COLLEGE, LOWER HUTT

THIS DEED OF AGREEMENT is made on the 18 day of July two thousand and thirteen (2013) BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the twenty fifth (25th) day of April, one thousand, nine hundred and eighty one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Bernard's College, Lower Hutt** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** in the fifth line in Clause 8 of the Deed of Agreement the words "five hundred and ninety (590)" be deleted and the words "six hundred fifteen (615) in 2013; six hundred and forty five (645) in 2014; and six hundred and sixty (660) in 2015" be added.
2. **THAT** in the eighth line in Clause 10 (b) of the Deed of Agreement the words "twenty-five (25) pupils" be deleted and the words "five percent (5%) (33 learners)" be added.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


