

SUPPLEMENTARY DEED OF AGREEMENT

ST ALBAN'S CATHOLIC SCHOOL, CHRISTCHURCH


THIS DEED OF AGREEMENT is made on the 12th day of December two thousand and five (2005) BETWEEN **THE ROMAN CATHOLIC BISHOP OF CHRISTCHURCH** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 25th day of May 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Alban's Catholic School, St Alban's, Christchurch** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "ninety four (94)" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and ten (110)" be substituted therefor.
2. **THAT** the words "five percent (5%) of the total roll" in the 9th line of clause 10(b) be deleted from the Agreement and the words "shall be limited at all times to 4 pupils" be substituted therefore.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
