

SUPPLEMENTARY DEED OF AGREEMENT

ST. ALBAN'S CATHOLIC SCHOOL

THIS DEED OF AGREEMENT is made on the *twentieth* day of *March* One Thousand nine hundred and ninety (1990) BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF CHRISTCHURCH a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 25th day of May 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Alban's Convent School CHRISTCHURCH as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Recital A on page 1 and the First, Second, Third and Fourth Schedules of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the original Deed of Agreement dated 25th day of May 1982 be amended by deleting the words "St Alban's Convent School Christchurch" from Recital A, from the Plan annexed to the Second Schedule and from the First, Third and Fourth Schedules.

2. THAT the words "St Alban's Catholic School, Christchurch" be substituted therefor.
3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
