

## SUPPLEMENTARY DEED OF AGREEMENT

### ST ANTHONY'S SCHOOL, PAHIATUA

THIS DEED OF AGREEMENT is made on the 7<sup>th</sup> day of October two thousand and ten (2010) between **THE ROMAN CATHOLIC BISHOP OF PALMERSTON NORTH** (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

#### WHEREAS

- A By Deed of Agreement bearing date the 20<sup>th</sup> day of May, One thousand, nine hundred and eighty two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Anthony's School, Pahiatua** as an integrated school (hereinafter referred to as "the school").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

#### **NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1 THAT the words "one hundred and twenty five (125) pupils" in the 5<sup>th</sup> line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and forty five (145) pupils, subject to the Proprietor providing adequate classroom provision and not enrolling any further non-preference students until there is space for them within the school's non preference roll quota" be substituted therefor.
- 2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
