

SUPPLEMENTARY DEED OF AGREEMENT

ST ANTHONY'S SCHOOL, SEATOUN, WELLINGTON

THIS DEED OF AGREEMENT is made on the 15th day of April
two thousand and thirteen (2013) **BETWEEN THE ROMAN CATHOLIC**
ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON, a "Corporation
Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part
and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education
(hereinafter referred to as "The Minister") of the second part.

WHEREAS

A By Deed of Agreement bearing date the 10th day of February, one thousand
nine hundred and eighty three (1983) as varied by any subsequent
supplementary agreements (hereinafter referred to as "the Deed of
Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the
Private Schools Conditional Integration Act 1975 established **St Anthony's**
School, Seatoun, Wellington as an integrated school (hereinafter referred to as
"the School").

B The Proprietor and the Minister are now agreed on the need to amend the Deed
of Agreement pursuant to section 7(9) of the Private Schools Conditional
Integration Act 1975.


**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
