SUPPLEMENTARY DEED OF AGREEMENT

BETWEEN THE ST BEDE'S COLLEGE TRUST BOARD a Body Corporate registered under the Charitable Trust Act 1957 (hereinafter with its

successors referred to as "the Proprietor") of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS:

- A. By Deed of Agreement bearing date the 26th day of December 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement") the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established St Bede's College, Christchurch as an integrated school (hereinafter referred to as "the School").
- B. The Proprietor has recently constructed a new Performing Arts Centre building on additional land owned by it.
- C. The Minister has agreed that this Land and Building is to be included as Integrated Property.
- D. The Proprietor and the Minister wish to vary the Deed of Agreement
 - (1) To amend the First Schedule.
 - (2) To amend the Second Schedule and to replace the Plan annexed to the Second Schedule with a new plan.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. To delete the First Schedule and replace it with a new First Schedule as now appears.
