SUPPLEMENTARY DEED OF AGREEMENT

ST BEDE'S COLLEGE, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the 4th day of February

One thousand nine hundred and eighty five (1985)

BETWEEN THE ST BEDE'S COLLEGE TRUST BOARD a body corporate registered under the Charitable Trust Act 1957 (hereinafter with its successors referred to as "the proprietor") of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 26th day of December 1982 for St Bede's College, CHRISTCHURCH

(hereinafter referred to as the "original Deed of Agreement")

B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 16th day of May 1983

C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "Seven hundred (700) pupils" in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "seven hundred and fifty (750) pupils" be substituted therefor and the words "five hundred (500) day pupils" in the seventh line in Clause 8 of the

original Deed of Agreement be deleted from that Agreement and the words "five hundred and fifty (550) day pupils" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 15 of that Agreement by deleting under the heading "Provide the following by remodelling or new construction" the words "Classrooms 2 x 58m²" and substituting therefor the words "Classrooms 3 x 58m²."

These items are to be completed by 31 March 1986

3 THAT the covenants conditions and restrictions contained and implied in the original Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the original Deed of Agreement is confirmed.
