

SUPPLEMENTARY DEED OF AGREEMENT

ST BEDE'S COLLEGE, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the 17th day of FEBRUARY

One thousand nine hundred and eighty six. (1986)

BETWEEN THE ST BEDE'S COLLEGE TRUST BOARD a body corporate registered under the Charitable Trust Act 1957 (hereinafter with its successors referred to as "the proprietor") of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A By Deed of Agreement bearing date the 26th day of December 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established ST BEDE'S COLLEGE CHRISTCHURCH as an integrated school.

B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "Seven hundred and fifty (750) pupils" in the 5th line of Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "Seven hundred and fifteen (715) pupils" be substituted therefor and the words "Five hundred and fifty (550) day pupils" in the seventh line of Clause 8 of the

Deed of Agreement be deleted from that Agreement and the words "five hundred and fifteen (515) day pupils" be substituted therefor.

2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
