

SUPPLEMENTARY DEED OF AGREEMENT

SAINT BERNADETTE'S SCHOOL, NAENAE

THIS DEED OF AGREEMENT is made on the 3 day of June
One thousand nine hundred and eighty-two (1982) BETWEEN THE
ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a
"Corporation Sole" (hereinafter with his successors referred to
as "the Proprietor") of the first part. AND HER MAJESTY THE QUEEN
acting by and through the Minister of Education (hereinafter
referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of
the Private Schools Conditional Integration Act 1975 signed
an integration agreement on the 28th day of April 1981 for
Saint Bernadette's School, Naenae.
- B The Proprietor and the Minister are now agreed on the need to
delete Clause eight (8) of that original Deed of Agreement and
to substitute a new Clause in its place pursuant to Section 7 (9)
of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. THAT Clause 8 in the said integration agreement for Saint
Bernadette's School, Naenae signed on the 28th day of April 1981
be deleted from that agreement.
2. THAT the following Clause be inserted therefore:
"8. THE School had a roll of one hundred and seventeen (117)
pupils as at the 30th September 1981 being the year when the
roll figures were last compiled. It is agreed by and between
the parties hereto that the maximum roll of the School shall
be one hundred and thirty-five (135).
3. THAT the covenants conditions and restrictions contained and
implied in the said Deed of Agreement shall be read and construed
subject to the modifications herein contained but in all other
respects the said Deed of Agreement is confirmed.
