

SUPPLEMENTARY DEED OF AGREEMENT

SAINT BERNARD'S PRIMARY SCHOOL, BROOKLYN, WELLINGTON

THIS DEED OF AGREEMENT is made on the ~~NINETEEN~~ day of ~~OCTOBER~~  
One thousand nine hundred and eighty-one (1981) BETWEEN THE  
ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a  
"Corporation Sole" (hereinafter with his successors referred  
to as "the Proprietor") of the first part AND HER MAJESTY THE  
QUEEN acting by and through the Minister of Education (hereinafter  
referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of  
the Private Schools Conditional Integration Act 1975 signed  
an integration agreement on the 20th day of August 1979 for  
St. Bernard's Primary School, Brooklyn, Wellington.
- B The Proprietor and the Minister are now agreed on the need to  
delete Clause B on page one and Clause 23 on page twelve of that  
original Deed of Agreement and to substitute new Clauses in their  
place pursuant to Section 7 (9) of the Private Schools Conditional  
Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED  
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. THAT Clause B on page one and Clause 23 on page twelve in the  
said integration agreement for Saint Bernard's Primary School,  
Brooklyn, Wellington signed on the 20th day of August 1979 be  
deleted from that agreement.
2. THAT the following Clauses be inserted therefor:  
"B The School is a Roman Catholic Primary School for Boys  
and Girls from new entrants to Form Two offering Education  
with a Special Character."  
"23 The School is a Primary School for Boys and Girls from new  
entrants to Form Two and shall remain so until such time as  
an agreement to a change in this organisation of the School  
is reached between the Proprietor and the Minister and the  
parties hereto enter into a Supplementary Deed of Agreement  
to give effect thereto."
3. THAT the covenants conditions and restrictions contained and implied  
in the said Deed of Agreement shall be read and construed subject to the  
modifications herein contained but in all other respects the said Deed  
of Agreement is confirmed.
