

SUPPLEMENTARY DEED OF AGREEMENT

ST BRENDAN'S SCHOOL, HERETAUNGA

THIS DEED OF AGREEMENT is made on the 23rd day of October one thousand nine hundred and ninety eight (1998) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date 1st day of October, one thousand, nine hundred and eighty-one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Brendan's School, Heretaunga** as an Integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the Deed of Agreement to replace the Second Schedule and the Plan attached thereto with a new Second Schedule and a new Plan pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1** THAT the Second Schedule of the Deed of Agreement and the Plan annexed thereto be deleted and the Second Schedule and Plan annexed hereto be substituted therefor.
- 2** THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.



SECOND SCHEDULE

Description of land, buildings and other improvements comprising the school premises

The School Premises:

All that part of the Proprietor's land as described in the **First Schedule** hereto, delineated in red on the annexed plan of the Proprietor's land, which forms part of this Schedule, **TOGETHER WITH** all the School buildings and other improvements thereon, **SAVE AND EXCEPT** Blocks E, F and K and the land more immediately surrounding the same more particularly delineated in blue on the annexed plan **TOGETHER WITH** a reservation in favour of the non-integrating areas more particularly delineated in blue on the annexed plan of full rights of access inter se and of ingress and egress to and from those areas over the access thereto shaded yellow on the annexed plan from and to Palmer Crescent, Heretaunga.
