

SUPPLEMENTARY DEED OF AGREEMENT

ST CATHERINE'S COLLEGE, KILBIRNIE

THIS DEED OF AGREEMENT is made on the ^{8th} day of ^{November} One thousand nine hundred and ninety five (1995) **BETWEEN THE SISTERS OF MERCY (WELLINGTON) TRUST BOARD** a body corporate registered under the Charitable Trusts Act 1957 (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the Twenty-sixth (26) day of March, One thousand, nine hundred and eighty-three (1983) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **ST CATHERINE'S COLLEGE, KILBIRNIE** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the Deed of Agreement to replace the First and Second Schedules and the Plan annexed to the Second Schedule with new Schedules and a new Plan.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 **THAT** the First and Second Schedules to the Deed of Agreement and the Plan annexed to the Second Schedule be deleted from the Deed of Agreement and the Schedules and Plan attached hereto be substituted therefor.
- 2 **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
