SUPPLEMENTARY DEED OF AGREEMENT

ST PATRICK'S SCHOOL, WAINUIOMATA

THIS DEED OF AGREEMENT is made on the day of February One thousand nine hundred and ninety that (1993) BETWEEN

THE ROMAN CATHOLIC ARCHBISHOP OF THE DIOCESE OF WELLINGTON

a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER

MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- April 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St. Patrick's School, Wainuiomata, as an integrated school (hereinafter referred to as "the School").
- The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 to enable boys to continue to attend the school up to Form 2, and to amend Clause 8 of the said Deed of Agreement.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the Deed of Agreement bearing date the 4th day of April 1981 is hereby amended by deleting Recital B and substituting therefore
- "B The School is a Roman Catholic Primary School for boys and girls from new entrants to form two offering Education with a Special Character".

- THAT Clause 23 on page 14 of the Deed of Agreement be amended by deleting the words "from new entrants to standard four and for" from that Agreement, and substituting the word "and".
- THAT the words "maximum roll of the School shall be two hundred and fifty (250) pupils" in lines 4 and 5 of Clause 8 on page 8 be deleted, and the words "maximum roll of the School shall be two hundred and seventy (270) pupils" be substituted therefor.
- THAT the Third Schedule of the Deed of Agreement be amended by deleting the words "Teaching space of 46.25m2, this accommodation is to be provided by 1995"
- THAT the supplementary integration agreement dated <u>5.</u> 26th day of October, one thousand nine hundred and ninety (1990) be consequently cancelled.
- THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
