## SUPPLEMENTARY DEED OF AGREEMENT

ST PATRICK'S SCHOOL, WAINUIOMATA

THIS DEED OF AGREEMENT is made on the Who day of Anthony One thousand nine hundred and eighty six (1986)

BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE

ARCHDIOCESE OF WELLINGTON a "Corporation Sole"
(hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY

THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

## WHEREAS

- A By Deed of Agreement bearing date the 14th day of April 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Patrick's School, Wainuiomata as an integrated school.
- <u>B</u> The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

## NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "one hundred and ninety (190)" in the 5th line in Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and fifteen (215)" be substituted therefor.

- 2 THAT the Third Schedule to the Deed of Agreement be amended by adding to the items listed under the heading "Building Requirements" the words "additional teaching space 65m<sup>2</sup>. This item to be completed by 1990.
- THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
