SUPPLEMENTARY DEED OF AGREEMENT

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY

COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES

- 1. THAT the words "three hundred and five (305)" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and sixty (360)" be substituted therefor.
- 2. THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading 'Building Requirements' the words "two (2) classrooms". This accommodation is be provided when required by the actual roll.
- 3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
