SUPPLEMENTARY DEED OF AGREEMENT

ST FRANCIS SCHOOL, POINT CHEVALIER

THIS DEED OF AGREEMENT is made on the 15<sup>th</sup> day of November

One thousand nine hundred and eighty four (1984) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 30th day of August 1980 for St Francis School, Point Chevalier

(hereinafter referred to as the "original Deed of Agreement")

B The Proprietor and the Minister are now agreed on the need to amend Clause 8 on the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY <sup>COVENANTED</sup> ~~CONVENANTED~~ AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "one hundred and fifty five (155)" in the 6th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "one hundred and seventy (170)" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 23 of that Agreement by adding under the heading "BUILDING REQUIREMENTS" the words

Teaching space 65m<sup>2</sup>

Resource workroom 14m<sup>2</sup>

Library/multipurpose room 56m<sup>2</sup>

These items are to be completed by 31 March 1986.

3 THAT the ~~COVENANTS~~<sup>COVENANTS</sup> conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
