

SUPPLEMENTARY DEED OF AGREEMENT

ST FRANCIS' SCHOOL, THAMES

THIS DEED OF AGREEMENT is made on the 29th day of July
One thousand nine hundred and eighty six (1986)
BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF
AUCKLAND a "Corporation Sole" (hereinafter with his
successors referred to as "the Proprietor") of the
first part AND HER MAJESTY THE QUEEN acting by and
through the Minister of Education (hereinafter referred
to as "the Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 22nd
day of March 1982 as varied by any subsequent
supplementary agreements (hereinafter
referred to as "the Deed of Agreement"),
the Minister and the Proprietor pursuant to
section 7(2) of the Private Schools
Conditional Integration Act 1975 established
ST FRANCIS' SCHOOL, THAMES (hereinafter
referred to as "the School") as an
integrated school.
- B The Proprietor and the Minister are now agreed
on the need to redefine the School Premises as
described in the Second Schedule to the Deed
of Agreement by entering into a supplementary
agreement pursuant to Section 7(9) of the
Private Schools Conditional Integration Act
1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE
PARTIES HERETO AS FOLLOWS:

- 1 THAT the Deed of Agreement bearing date the
22nd day of March 1982, is hereby amended
by deleting and cancelling the Second Schedule
and annexed Plan.

2 **THAT** the Schedule and Plan attached to this Supplementary Deed of Agreement are hereby substituted as the Second Schedule defining the School Premises in the Deed of Agreement.

3 **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
