

SUPPLEMENTARY DEED OF AGREEMENT

ST. FRANCIS XAVIER SCHOOL, TAWA

THIS DEED OF AGREEMENT is made on the 30th day of March
One thousand nine hundred and ninety-three (1993) BETWEEN
THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF
WELLINGTON a "Corporation Sole" (hereinafter with his
successors referred to as "the Proprietor") of the first
part and HER MAJESTY THE QUEEN acting by and through the
Minister of Education (hereinafter referred to as "The
Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 1st day of
September 1981 as varied by any subsequent
supplementary agreements (hereinafter referred to as
"the Deed of Agreement"), the Minister and the
Proprietor pursuant to section 7(2) of the Private
Schools Conditional Integration Act 1975 established
St. Francis Xavier School, Tawa, as an integrated
school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the
need to amend Clause 8 of the Deed of Agreement
pursuant to Section 7(9) of the Private Schools
Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the words "maximum roll of the School shall be
two hundred and five (205) pupils" in lines 4 and 5
of Clause 8 on page 8 be deleted, and the words
"maximum roll of the School shall be two hundred and
thirty (230) pupils" be substituted therefor.

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
