

SUPPLEMENTARY DEED OF AGREEMENT

ST FRANCIS DE SALES SCHOOL, ISLAND BAY, WELLINGTON

THIS DEED OF AGREEMENT is made on the 28th day of January two thousand and ten (2010) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the twenty-eighth (28th) day of March, one thousand, nine hundred and eighty three (1983) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Francis de Sales School, Island Bay** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT** the words "two hundred and ninety (290)" in the fourth line in Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and twenty (320) students subject to the Proprietor addressing the existing deficiency of two teaching spaces" be substituted therefor.
- 2. THAT** in clause 10 (b) of the Deed of Agreement the word "fifteen (15) pupils out of the total roll" be deleted from that Agreement and the words "five (5) percent of the maximum roll" be substituted therefor.
- 3. THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


