

SUPPLEMENTARY DEED OF AGREEMENT

ST IGNATIUS' SCHOOL, ST. HELIERS

THIS DEED OF AGREEMENT is made on the 27<sup>th</sup> day of August  
One thousand nine hundred and ninety-three (1993) BETWEEN  
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a  
Corporation Sole (hereinafter with his successors referred  
to as "the Proprietor") of the first part and HER MAJESTY  
THE QUEEN acting by and through the Minister of Education  
(hereinafter referred to as "The Minister") of the second  
part

WHEREAS

- A** By Deed of Agreement bearing date the 3rd day of August 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St. Ignatius' School, St. Heliers, as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend Recital B on page 1 and Clause 23 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1.** THAT the Deed of Agreement bearing date the 3rd day of August 1982 is hereby amended by deleting Recital B and substituting therefore
- "B** The School is a Roman Catholic Primary School for boys and girls from new entrants to Standard Four (4) offering Education with a Special Character".

2. THAT Clause 23 on page 11 of the Deed of Agreement be amended by deleting the words "girls from new entrants to Form Two (2) and boys from new entrants to Standard Four (4)" from that Agreement, and substituting the words "boys and girls from new entrants to Standard Four (4)".

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
