

SUPPLEMENTARY DEED OF AGREEMENT

ST JOHN THE EVANGELIST SCHOOL, OTARA

THIS DEED OF AGREEMENT is made on the day of
One thousand nine hundred and ninety five (1995) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a
Corporation Sole (hereinafter with his successors referred to
as "the Proprietor") of the first part and HER MAJESTY THE
QUEEN acting by and through the Minister of Education
(hereinafter referred to as "The Minister") of the second
part.

WHEREAS

- A** By Deed of Agreement bearing date the 30th day of August 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St John the Evangelist Primary School, Otara**, as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to redefine the Proprietor's Land and the School premises as defined in the First and Second Schedules to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the Deed of Agreement bearing date the 30th day of August 1980, is hereby amended by deleting and cancelling the Second Schedule and annexed Plan.

2. **THAT** the Schedule and Plan attached to this supplementary Deed of Agreement are hereby substituted as the Second Schedule defining the School Premises in the Deed of Agreement.

3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

SECOND SCHEDULE

Description of land, buildings and other improvements comprising the School Premises.

The School Premises:

All that part of the Proprietor's land as described in the **First Schedule** hereto, delineated in red on the annexed plan of the proprietor's land, which forms part of this Schedule, **TOGETHER WITH** all the School buildings and other improvements thereon **SAVE AND EXCEPT** the two Blocks and the land immediately surrounding the same more particularly delineated on the annexed plan shown in diagonal shading (hatched).

AND with a right in common with the proprietor his agents servants and licensees to the use of the area shaded red on the said plan for ingress and egress and for the parking of vehicles used by persons lawfully attending the School Premises.
