SUPPLEMENTARY DEED OF AGREEMENT

ST JOHN BOSCO SCHOOL, NEW PLYMOUTH

THIS DEED OF AGREEMENT is made on the *25* day of *July*

One thousand nine hundred and eighty-four (1984) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 22nd day of February 1983 for St John Bosco School, NEW PLYMOUTH (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

- 1 THAT the words "one hundred and ten (110) pupils" in the 4th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "one hundred and twenty-six (126) pupils" be substituted therefor.
- 2 THAT the words under "Building Requirements" on page 22 of the Third Schedule attached to the said Deed of Agreement be deleted therefrom and the following words be substituted therefor

"Provide by remodelling or new construction	
Teaching space of	123m ²
Bookroom of	28m ²
Resource workroom of	14m ²
Staffroom of	14m ²
Staff Kitchen of	4m ²
Principals Office of	11m ²
Casualty/Sickroom of	9m ²
Storage Totalling	18.5m ²

Female Staff Toilet suite containing

1 WC 1 WHB and 1 STDU

Boy's toilet 1 WHB

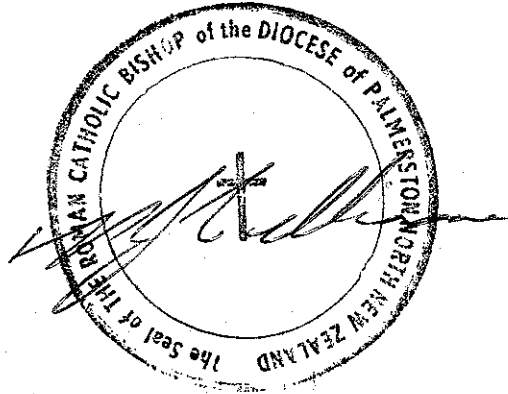
Girls toilet 2 WHB "

These items to be completed by 31 March 1987.

3 THAT the covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
