THIS DEED OF AGREEMENT is made on the 16 day of MARCH
One thousand nine hundred and eighty-three (1983) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part <u>AND HER MAJESTY THE QUEEN</u> acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

## WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 30th day of August 1980 for St. John the Evangelist Primary School, Otara (hereinafter referred to as the "original Deed of Agreement")
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 and the Third Schedule of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

## NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

- 1. THAT the words "three hundred (300) pupils" in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "three hundred and forty-five (345) pupils" be substituted therefor.
- 2. THAT the Third Schedule to the original Deed of Agreement be amended on page twenty-two (22) of that agreement under the heading BUILDING REQUIREMENTS by adding as new items the words:
  "Provide the following accommodation:

Additional classroom space of 128m2 Resource workroom Junior-School  $14m^2$  Additional staffroom accommodation of  $9m^2$  Additional sickroom accommodation of  $5m^2$ "

The first item is to be completed by 31 March 1983. The other items are to be completed by 31 March 1984.

3. THAT the covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
