THIS DEED OF AGREEMENT is made on the One thousand nine hundred and ninety (1996) BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 26th day of December 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St John's College, Hastings as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to redefine the School Premises as defined in the Second Schedule to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY

COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES

HERETO AS FOLLOWS:

- 1. THAT the Deed of Agreement bearing date the 26th day of December 1982 is hereby amended by deleting and cancelling the Plan annexed to the Second Schedule.
- 2. THAT the Plan attached to this Supplementary Deed of Agreement is hereby substituted as the Plan annexed to the Second Schedule defining the School Premises in the Deed of Agreement.

- 3. THAT the Deed of Agreement bearing date the 26th day of December 1982 is hereby amended by adding to the Third Schedule the "Amendments to Capital Work Requirements" attached to this Supplementary Deed of Agreement.
- 4. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
