

## SUPPLEMENTARY DEED OF AGREEMENT

### ST JOHN'S GIRLS' SCHOOL, INVERCARGILL

THIS DEED OF AGREEMENT is made on the 20 day of April, two thousand and nine (2009) BETWEEN **ST JOHN'S GIRLS' SCHOOL INCORPORATED** (the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A** By Deed of Agreement bearing date the 10<sup>th</sup> day of September 1993 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St John's Girls' School, Invercargill** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend clause 20 and Background C of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

### NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "one hundred and twenty five (125) pupils" in line 5 of Clause 17 of the deed of Agreement be deleted and the words "one hundred and fifty (150) pupils" be substituted therefor.
2. **THAT** the words in Clause 18(d) line 9 of the Integration Agreement "four (4) pupils that being" and line 11 "at the time of integration" be deleted.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

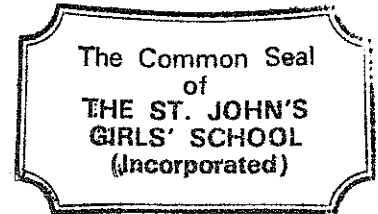
