

SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 13th day of September
One Thousand nine hundred and eighty eight (1988) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON a
"Corporation Sole" (hereinafter with his successors
referred to as "the Proprietor") of the first part and HER
MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter referred to as "The Minister") of
the second part

WHEREAS

A By Deed of Agreement bearing date the 26th day of
October one thousand nine hundred and eighty one (1981) as
varied by any subsequent supplementary agreements
(hereinafter referred to as "the Deed of Agreement"), the
Minister and the Proprietor pursuant to section 7(2) of the
Private Schools Conditional Integration Act 1975
established St. Joseph's School, FAIRFIELD as an integrated
school.

B The Proprietor and the Minister are now agreed on the
need to amend Recital B on Page 1 and Clause 23 of
the Deed of Agreement pursuant to Section 7(9) of the
Private Schools Conditional Integration Act 1975.

1. THAT the words "for boys from new entrants to standard four and for girls from new entrants to form two" in recital B on page one and in lines 1 and 2 of Clause 23 of the Deed of Agreement be deleted from that Agreement and the words "for boys and girls from new entrants to Form Two (2)" be substituted therefor.

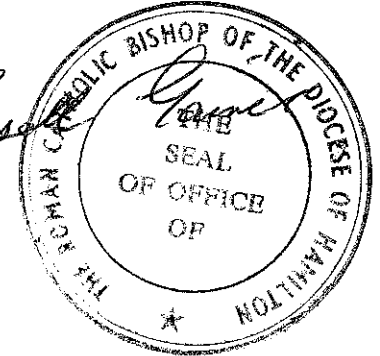
