

**SUPPLEMENTARY DEED OF AGREEMENT****ST JOSEPH'S SCHOOL, HASTINGS**

**THIS DEED OF AGREEMENT** is made on the 11<sup>th</sup> day of *December* one thousand nine hundred and ninety-eight (1998) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

**WHEREAS**

- A By Deed of Agreement bearing date the 7th day of December, one thousand nine hundred and eighty two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Joseph's School, Hastings** as an Integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister wish to vary the Deed of Agreement to replace the Plan attached to the Second Schedule with a new Plan and to add a new Third Schedule pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1** **THAT** the Plan attached to this Supplementary Deed of Agreement is substituted as the Plan defining the School Premises in the Deed of Agreement.

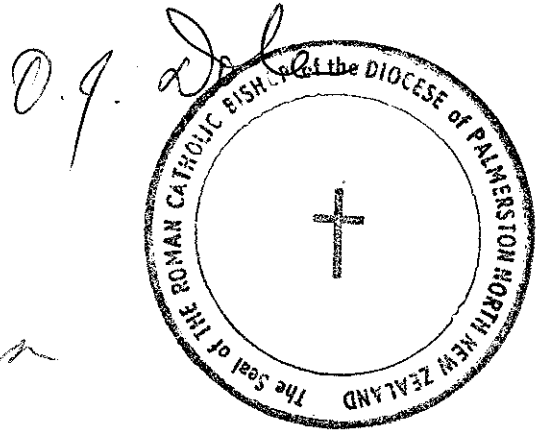

**SCHEDULE****New Third Schedule****“THIRD SCHEDULE****WORKS TO BE CARRIED OUT BY THE PROPRIETOR IN RELATION TO THE INTEGRATED SCHOOL**

These works are to be planned, executed and paid for by the Proprietor subject to the provisions of this schedule in relation to the buildings and associated facilities to bring them up to the minimum standard for a comparable state school. All work is to be carried out by competent tradesmen or in a workmanlike manner to Ministry of Education standards.

**Description of Work for Block A****Resource Area 1**

- (a) Upgrade lighting
- (b) Redecorate interior
- (c) Upgrade floor covering

**Store Area 7**

- (a) Upgrade lighting
- (b) Redecorate interior
- (c) Upgrade floor covering
- (d) Replace North side windows

**Corridor Area 8**

- (a) Redecorate interior
- (b) Ensure double hung windows operate effectively.”
