

SUPPLEMENTARY DEED OF AGREEMENT

ST. JOSEPH'S MAORI GIRLS' COLLEGE, GREENMEADOWS


THIS DEED OF AGREEMENT is made on the 21st day of December
One thousand nine hundred and ninety-two (1992) BETWEEN
THE INSTITUTE DE NOTRE DAME DES MISSIONS TRUST BOARD, a
"Body Corporate" (hereinafter with its successors referred
to as "the Proprietor") of the first part and HER MAJESTY
THE QUEEN acting by and through the Minister of Education
(hereinafter referred to as "the Minister") of the second
part

WHEREAS

- A By Deed of Agreement bearing date the 12th day of
September 1982 as varied by any subsequent
supplementary agreements (hereinafter referred to as
"the Deed of Agreement"), the Minister and the
Proprietor pursuant to section 7(2) of the Private
Schools Conditional Integration Act 1975 established
St. Joseph's Maori Girls' College, Greenmeadows, as
an integrated school (hereinafter referred to as "the
School").
- B The Proprietor and the Minister are now agreed on the
need to amend Recital B on page 1 and Clauses 5 and
24 of the Deed of Agreement pursuant to Section 7(9)
of the Private Schools Conditional Integration Act
1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the words "The school is a Roman Catholic
Secondary Boarding School for Girls" in line 1 of
Recital B on page 1 be deleted from the Agreement,
and that the words "The school is a Roman Catholic
secondary boarding and day school for girls" be
substituted therefor.

2. THAT the words "Secondary School" in line 2 of Clause 5 on page 6 be changed to "Secondary Boarding and Day School" and that the words "and attached to which is a boarding establishment operated by the Proprietor as an essential element in the life of the School" in lines 4 and 5 of Clause 5 on page 6 be deleted.

3. THAT the words "The school is a Secondary Boarding School for Girls only" in line 1 of Clause 24 on page 13 of the Agreement be deleted from the Agreement, and that the words "The school is a Roman Catholic secondary boarding and day school for girls" be substituted therefor.

4. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
