THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF DUNEDIN a

"corporation sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and HER

MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 6th day of October 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St. Joseph's School, Oamaru, as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY

COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES

HERETO AS FOLLOWS:

in the 5th line of Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and twenty five (325) pupils" be substituted therefor.

IA.B.

- THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading 'Building Requirements' the words '2 additional teaching spaces of 128m2, increase junior resource workroom by 14m2, increase casualty sickroom by 5m2, staff kitchen of 4.5m2'. This accommodation is to be provided by 1993.
- THAT the covenants conditions and restrictions 3.___ contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
