

**SUPPLEMENTARY DEED OF AGREEMENT**

**ST JOSEPH'S SCHOOL, ONEHUNGA**

THIS DEED OF AGREEMENT is made on the <sup>9<sup>th</sup></sup> day of <sup>FEBRUARY</sup> ~~six (1986)~~ <sup>seven (1987)</sup>  
One thousand nine hundred and eighty ~~six (1986)~~ <sup>seven (1987)</sup>  
BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF  
AUCKLAND a "Corporation Sole" (hereinafter with his  
successors referred to as "the Proprietor") of the  
first part and HER MAJESTY THE QUEEN acting by and  
through the Minister of Education (hereinafter referred  
to as "the Minister") of the second part

**WHEREAS**

- A** By Deed of Agreement bearing date the 5th day  
of May 1981 as varied by any subsequent  
supplementary agreements (hereinafter referred  
to as "the Deed of Agreement"), the Minister  
and the Proprietor pursuant to Section 7(2) of  
the Private Schools Conditional Integration  
Act 1975 established **St Joseph's School, Onehunga**  
as an integrated school.
- B** The Proprietor and the Minister are now agreed on  
the need to amend Clause 8 of the Deed of  
Agreement pursuant to Section 7(9) of the  
Private Schools Conditional integration Act  
1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY  
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE  
PARTIES HERETO AS FOLLOWS:**

- 1** **THAT** the words "three hundred (300) pupils"  
in the 5th line in Clause 8 of the Deed of  
Agreement be deleted from that Agreement and  
the words "three hundred and thirty (330) pupils"  
be substituted therefor.
- 2** **THAT** the Third Schedule to the Deed of Agreement  
be amended by adding under the heading "Provide by  
new construction or remodelling" the words  
"Additional classroom 65m<sup>2</sup>  
Junior school resource room 14m<sup>2</sup>"  
This item to be completed by 1990.
